The Russian Hall's Rental Subsidy Program

Posted: March 18th, 2024

Deadline to submit: April 26th, 2024

Notification of results: no later than May 31st, 2024

All requested activities must take place in 2025.

The Federation of Russian Canadians of BC (FRCBC) is accepting applications for subsidized and free rental space for community events, rehearsals and performances taking place in 2025. The program is open to individuals as well as community groups that demonstrate financial need, have experienced or continue to experience marginalization and oppression, and whose activities align with the values of the FRCBC.

The FRCBC operates the Russian Hall as a space dedicated to carrying on the cooperative spirit of its founders by: hosting performing arts activity; programming community-based activity; and accommodating and promoting civic engagement.

Eligible groups include but are not limited to:

- Indigenous artists or Indigenous led organizations
- Racialized artists or organizations led by racialized community members
- Artists or organizations led by members of the LGBTQAI2+ community
- Artists or groups led by individuals with a lived experience of disability
- Groups with an environmental focus
- Labour/worker-focused organizations
- Other social justice–focused artists/organizations.

We encourage members of equity-seeking communities to self-identify as they feel comfortable.

Subsidies

Subsidies are awarded in the form of credits for hours or days with the maximum allotted time being 14 days. These credits can be used to book the space in the same way that a commercial client would book rentals.

- Rentals are on a first-come, first-served basis and are subject to availability.
- Anything less than a one-week rental will be able to be booked no more than three months in advance.
- We may not be able to grant subsidy requests in their entirety, so please be sure to
 include in your application whether you would be willing to pay for additional time
 needed beyond the 14-day maximum.
- Recipients will be notified by email no later than May 31st, 2024. All subsidies awarded
 must be used in 2025 and cannot be carried forward into future years.
- Hours are not transferable to other companies or individuals.
- Grantees must sign and adhere to the Russian Hall Rental Agreement and abide by all conditions therein.
- Recipients are required to obtain general liability and property damage insurance for the duration of the rental in respect of the Rental Space and the building in which the Rental

Space is situated with a combined limit of no less than \$2,000,000 per occurrence and will name The Federation of Russian Canadians of British Columbia as the additional insured. The Grantee must provide the FRCBC with a copy of the insurance certificate on or before the rental start date.
